COMMITMENTS IS AN
OVERARCHING TRANSFORMATIONAL
STRATEGY THAT ARTICULATES
THE NATURAL CHARACTER OF
MEDITERRANEAN BEACHES AND
THE ACTION COMMITMENTS TO BE
UNDERTAKEN TO ACHIEVE ITS LONGTERM CONSERVATION.

The Mediterranean coastline is a special and unique natural asset that supports much of the region's economy and community wellbeing. The beaches along the Mediterranean range from urban or semi-urban environments, glitzy and glamorous to perfectly secluded hamlets. Almost every country that has a Mediterranean coastline has sandy beaches and the unique seagrass *Posidonia oceanica* in its nearshore waters.

Today, the region is the world's leading tourism destination in terms of both international and domestic tourism and beach tourism is a key economic driver for coastal regions. The environmental pressures from human-induced activities along these coastal areas are taking a

toll on the conservation of its natural landcape, its biodiversity and the tourism industry itself as they reduce the attractiveness of coastal destinations. Moreover, the region is particularly vulnerable to the effects of global climate change, with coastal areas in particular facing heightened challenges such as severe erosion, storm events, higher sea and air temperatures and flooding.

Much of the Mediterranean coastline is now a highly managed one. Common practices on many beaches include actions such as the removal of Posidonia banquettes, formed largely from the leaves of seagrasses washed ashore, sand and organic matter. The seagrass and the consequent banquettes occasionally formed on Mediterranean shorelines are increasingly recognised for their ability to play a catalytic role in climate change adaptation and as key biodiversity reservoirs. The vast underwater meadows formed by Posidonia plants contribute to improved water quality, increased marine biodiversity and the reduction of wave energy particularly during heavy storms. The banquettes can protect the coast from erosion and sand loss and support the overall stability of nearby dune systems. Posidonia constitutes a valuable Mediterranean natural asset that plays a fundamental role in protecting the coastal environment.

Future management needs to be responsive to changing conditions on these dynamic environments, manage erosion risks, biodiversity loss and tourism growth to achieve positive net impact. This needs creative solutions such as using nature-based solutions with Posidonia and increasing efforts on knowledge, communication, coordination and the development of good policies and practices.



WHY A JOINT CHARTER OF COMMITMENTS?

The Joint Charter of Commitments for Mediterranean beaches with Posidonia aims to create a stable collaboration between country governments at any administrative level and concerned local stakeholders across the Mediterranean to promote sustainable and nature-based management practices for natural beaches with Posidonia oceanica. It contributes to the creation of an engaged Mediterranean-wide stakeholder network and aims to raise awareness on the importance of protecting these valuable marine and coastal ecosystems.

Signing the Charter of Commitments means forming part of an extensive network of regional governments, municipalities and stakeholders across the Mediterranean who commit to implementing actions in favour of the protection and conservation of natural beaches with Posidonia. It signals an authentic interest to participate in local development and create valuable synergies to conserve a uniquely Mediterranean natural asset and preserve it for future generations. Signatories of the Charter are ambassadors of these shared principles and signal a commitment to creating and implementing a plan of action for long-term conservation.

The Charter is a comprehensive approach that seeks to:

- Recognise Mediterranean beaches for their unique, natural and authentic character.
- Manage Mediterranean beaches with respect and paying particular attention to the fauna and flora that inhabit them.
- Enhance the cultural identity of Mediterranean beaches.
- Develop seaside economies in a manner that takes into account the **benefits** of *Posidonia oceanica* in **sustaining the quality of the coast.**
- Promote healthy beaches that reflect the good quality of bathing waters and marine ecosystems.
- Promote biodiversity and the preservation of these beaches for future generations.
- Preserve the beauty and uniqueness of Mediterranean coastal landscapes.
- Provide clean, waste-free beaches that are accessible to all.
- Conserve the ecological features of beaches to increase the resilience of Mediterranean coasts to climate change.



WHO CAN SIGN THE CHARTER OF COMMITMENTS?

The Joint Charter of Commitments for Mediterranean beaches with Posidonia seeks to gain the support of Mediterranean multi-level country governments, municipalities, stakeholders and civic actors across sectors. It aims to create a stable network of local, regional and national administrations that promotes the creation of meaningful collaborations with concerned local stakeholders and communities.

However, it is important to note that the Charter is open to signature by all organisations, institutions and stakeholders and encourages participation within each actor's capacities and resources.



MISSION OF THE CHARTER



- Promote the commitment to this Charter among stakeholders
- Participate in the development of knowledge concerning the ecosystem of the beach and the banquette and more generally of Mediterranean coastal ecosystems;
- Raise awareness, inform, educate or enhance the capacity building of beach stakeholders, in order to better understand and protect the banquettes and Mediterranean coastal systems;
- Change collective and individual behaviours and practices with regards to the presence of the Posidonia banquettes on the beaches, so as to act in a manner that benefits their conservation;

- Promote and disseminate best management practices for beaches that respect their naturalness and encourage the sharing of experiences;
- Participate to mainstream nature-based solutions and ecosystem-based approaches in Mediterranean coastal management;
- Comply with existing regional, national and European regulations concerning Posidonia meadows and banquettes or promote the application of a regulation in countries or regions where it does not exist
- 8 Share learnings and support those who are starting out on this process.

The Joint Charter contributes to the Sustainable Development Goals, the Post 2020 Global Biodiversity Framework, and aligns with the objectives of UN Decade of Ocean Science for Sustainable Development (2021-2030) to support efforts for adaptation strategies and science-informed policy responses to global change, reverse the cycle of decline in ocean health and support the implementation of the Agenda 2030.







OUR CONTRIBUTIONS TO SDG



Take urgent action to combat climate change and its impacts. Strengthen resilience and adaptive capacity to climate-related hazards; integrate climate change measures into policies, strategies and planning; and improve education, awareness-raising and human and institutional capacity on climate change mitigation, adaptation, impact reduction and early warning.



Conserve and sustainably use the oceans, seas and marine resources for sustainable development. Protect and restore marine and coastal ecosystems; increase scientific knowledge for Ocean Health; conserve coastal and marine areas.

WHAT IS THE VALUE OF THE COMMITMENTS?



The value of the commitments is based on their capability to address local issues related to the management of Posidonia banquettes and Posidonia coastal ecosystems in the Mediterranean. Commitments should be meaningful in nature, preferably based on technical and scientific data as well as management measures that have been proven to be sustainable and effective. Weak or vague commitments run the risk of discrediting the collective approach of the Charter and wasting the actor's resources with little return for the efforts made.

Each commitment should be realistic and achievable in relation to the abilities and capabilities of the actor who is making it, and implemented within a defined timeframe.

The Charter aims to propose a series of commitments based on the common values and objectives previously described and are tailored to meet the interests, priorities and means of actions of different groups of actors, including administrations and beach managers, economic actors, associations and foundations and educational actors, among others.

Progressing to recognise and conserve the natural character of Mediterranean beaches and the action commitments to be undertaken to achieve its long term conservation.

HOW CAN COUNTRY GOVERNMENTS AT ANY ADMINISTRATIVE LEVEL COMMIT TO THE CHARTER?

Country governments, whether they are local, regional or national, can commit to the Charter through actions that define final intended impacts as well as those that work to establish necessary preconditions (enabling environment and policy actions).

Stakeholders can commit to establishing an enabling environment for Mediterranean Posidonia beaches through direct and indirect measures such as increasing research on beach dynamics, Posidonia meadows and banquettes at their sites. Commitments can also include interventions or programmes designed to directly and indirectly improve local participation and consultation, mass media and public awareness campaigns, financing long-term monitoring programmes to oversee nature-based restauration and conservation activities in beaches, and actions that fall under leadership and governance.

These enabling actions are necessary conditions for promoting effective policies and regulations that can include strategies, policies, interventions or incentive programmes that aim to improve *Posidonia oceanica* and Posidonia banquette conservation both directly and indirectly. This can include regulations for addressing a concerted and pro-conservation management of Posidonia banquettes in the areas, managing boat anchoring and trawling impacts or water quality, policy actions that are relevant to develop guidelines and protocols for beach management

with Posidonia banquettes or actions using Nature-based Solutions with Posidonia banquettes for restoring the coastal dune/beach or its marine environment. Given that tourist behaviour is largely shaped by the **existing destination marketing** and **tourism policies**, relevant policies, programmes or incentives that work to influence and conserve the natural character of Mediterranean beaches with Posidonia are particularly relevant when addressing commitments orientated towards tourism.

The final intended impacting actions include commitments designed to directly improve the natural conservation of the Posidonia dune/beach environment. This can include operational commitments to not remove banquettes from all beaches, particularly in sensitive areas under erosion processes, key biodiversity areas and protected areas, including Natura 2000 sites. Furthermore, impact actions can include commitments towards increasing the surface area of designated protected areas with Posidonia considering the marine and coastal integration of both components in their management.



In the case of administrations and other entities responsible for beach management, the Charter proposes the following specific commitment focal areas, in addition to which signatories are invited to propose and develop additional, actor-specific commitments as indicated before:



Beaches with Posidonia help protect from coastal erosion, retain sand and enhance biodiversity.

- Provide the resources to finance and/or use management techniques that promote the sustainable management and preservation of Posidonia banquettes and Mediterranean coastal ecosystems overall.
- Avoid the use of heavy machinery, especially in sensitive areas.
- Where Posidonia banquette removal is authorised, use only soft methods (manual collection, sifting) that allow the removal of waste only while preserving Posidonia banquettes.
- Before deciding on which management technique to implement, develop a baseline study to discover and understand management methods that promote the preservation of Posidonia banquettes and coastal ecosystems (e.g. leaving Posidonia banquettes untouched; temporarily removing banquettes during summer season, storing them on-site and returning to the shoreline after the tourist season).

Develop and implement awareness raising and educational activities on

Posidonia oceanica banquettes and meadows addressed to all beach users.

- Promote and/or finance research activities to improve existing knowledge on the relationships between *Posidonia oceanica* and coastal ecosystems.
- 7 Include in calls for tenders for beach concessions a specific clause promoting the sustainable management of Posidonia banquettes.
- 8 Other actions that target the common objectives and support the enabling actions for Posidonia banquette management (e.g. the support and promotion of local legislation that drives the protection of Posidonia banquettes)


ADMINISTRATIONS AND BEACH MANAGERS AT THE LOCAL LEVEL HAVE A CENTRAL ROLE IN MANAGING THE COAST

Whereas regional or country policies may establish broad shoreline and management plans or establish uses of domain, local councils and municipalities or protected area managers (for those particular situations) establish the specific regulations for marking the use of coastal areas, zoning of activities and maintaining services for beach users.

Developing an action plan sets the framework to investigate present conditions and future actions that will contribute to maintaining Mediterranean Posidonia beaches. Commitments towards the formalisation of action plans under a framework can facilitate decision-making.

SMART ACTION COMMITMENTS TO ADDRESS THESE OBJECTIVES

Each commitment or set of commitments that the signatory chooses to adhere to through their participation in the Charter is put into practice through the definition of **SMART goals**. By following a set of clearly defined criteria, signatories are able to establish realistic targets with meaningful and achievable outcomes. SMART goals aim to provide a framework for developing specific, measurable, achievable, relevant and time-bound targets and increase the likelihood of their successful achievement as well as the efficient use of available resources.



Example of how a commitment can be formulated to follow the SMART criteria:

"My municipality commits to running an awareness-raising programme for local residents and
beach goers promoting the value of Posidonia
beaches and to reduce banquette removal in all
protected areas as well as in those with erosion.
The programme will run from 2022 to 2025. We
will monitor the development of this commitment
through four annual reports (one per year) on the
results achieved including the percentage of visitors participating in the programme, evolution
of perspectives regarding Posidonia banquettes
as well as potential adjustments that need to be
made throughout the development of the programme in order to achieve the desired final results".

An online platform has been created for the mobilisation of the Joint Charter of Commitments for Mediterranean beaches with Posidonia. The platform provides the tools for identifying and developing commitments and goals specific to each signatory, as well as information on the importance of Posidonia beach-dune systems in the Mediterranean and their conservation. The commitments and goals are developed through the Action Commitment Form, which outlines a plan of action for fulfilling the proposed commitments of each actor following the SMART criteria.

Upon developing the commitments, each actor signs the Charter through the online platform.

Signatories have the opportunity to showcase the development of their commitments through online testimonies that highlight these important achievements. The signatory's logo is added to the online platform to promote their commitment to the Joint Charter and encourage other actors to share these common values and work together to preserve Mediterranean natural beaches.

FOOTNOTES

The Joint Charter of Commitments is open for signature by all organizations and stakeholders. It is not a formal certification and can be adapted by any country or region. Participation in the Charter is free of charge and provides an initial step towards supporting the gradual implementation of good practices.

We hope that in the near future the administrations forming part of the Charter are able to coordinate efforts, exchange experiences and build benchmarks of good practices as well as to develop community incentives to keep building the vision for **Beaches of Mediterranean Character.**

The present Charter originates from the POSBEMED2 initiative, funded by the Interreg-MED programme and is designed to address the challenges Mediterranean beaches currently face promoting nature-based management and supporting planning strategies that acknowledge the value of Posidonia beach-dune environments. It is built through the collaboration between regional governments, beach managers, scientific partners, tourism actors, associations and local communities.
